IVM Chemicals will send a confirmation of receipt of bid email. Late tenders will not be considered.

IVM Chemicals shall not consider any tender that arrives after the deadline for submission. Any tender received by IVM Chemicals after the deadline for submission of tenders shall be declared late and rejected.

Tenders will be received up to the time and date stated. Those received before the due date will be retained unopened until then. It is the responsibility of the tenderer to ensure that their tender is delivered not later than the appointed time.
